2. Approval of the Agenda:

4. Chairperson's Report:

Highlights:

- The land transfer to restore property lines has been completed to restore the total to 143.5 acres. The Department of Transportation and Infrastructure Renewal has paid all legal bills incurred during the land transfer.
- The NAPA application has some final details that need to be revised before approval by Executive Council.
- A change in our current bylaws is required before charitable status can be granted.
- We currently have only one board member from government. A second board member needs to be appointed.
- An "off leash" agreement is needed to enable the use of government land adjacent to Upton property. This process was initiated in 2013.
- It has been determined that fencing for adjacent property to enable off leash use would cost in excess of \$10,000.
- The province has given the Trust a "grant in lieu" to cover the provincial portion of the property taxes. We do however owe in excess of \$20,000 in taxes to the City of Charlottetown who has refused to provide a grant in lieu.
- The option to purchase 2 acres of land adjacent to Beach Grove has been extended to 2019.

- The Upton Farmlands sign has been refurbished by the Department of Transportation and Infrastructure Renewal. Many thanks to Brian Thompson for facilitating this.
- The culverts on the Upton property have been repaired but are in need of replacement.
- Ten acres has been planted in the Confederation Forest on the south side of the highway and planting will continue Canada day

5. **The Treasurer's Report** was presented by Doug MacDonald. (Copies were provided.)

6. Nominating Committee Report: (Allan Pendergast)
